³ Foreign Politically Exposed Persons are individuals who are or have been entrusted with prominent public functions by a foreign country such as Heads of State or of government; senior politicians; senior government, judicial or military officials; senior executives of state owned corporation;, important political party officials.

⁴ Domestic Political Exposed Persons are individuals who are or have been entrusted domestically with prominent public functions, i.e. Heads of State or of government; senior politicians; senior government, judicial or military officials; senior executives of state owned corporations; important political party officials.

⁵ These are persons who are or have been entrusted with a prominent function by an international organization, i.e. directors, Deputy Directors and Members of the Board or equivalent functions.

⁶ High net-worth individuals are persons holding financial assets (excluding their primary residence) with a value greater than \$1 million dollars (EC).

⁷ Legal Arrangement refers to express trusts or other similar legal arrangements such as fiducie, treuhand and fideicomiso. Express trust refers to a trust clearly created by the settlor, usually in the form of a document, example, a written Deed of Trust. They are to be contrasted with trusts which come into being through the operation of the law and which do not result from the clear intent or decision of a settlor to create a trust or similar arrangement.

⁸ Legal persons refer to any entities other than natural persons that can establish a permanent customer relationship with a financial institution or otherwise own property such as companies, body corporate, foundations, partnership, associations and other relevantly similar entities.

⁹ Intermediary means a person who has or seeks to establish a business relationship or to carry out an occasional transaction on behalf of his or her customer / client with a service provider, so that the intermediary becomes a customer of the service provider.



SECTION V

This application to register as a non-regulated service provider is made under regulation 3 of the Anti-Money Laundering and Terrorist Financing (Non-Regulated Service Providers) Regulations, 2022.

I am aware that, under regulation 12 of the Anti-Money Laundering and Terrorist Financing (Non-Regulated Service Providers) Regulations 2022, it is an offence to –

- (a) provide any information, make any representation or submit any document that I know, suspect or have reasonable grounds to suspect to be false or materially misleading or do not believe to be true; or
- (b) recklessly provide any information, make any representation or submit any document or return that is false or materially misleading.

And a Non-Regulated Service Provider who commits this offence is liable –

- (a) on summary conviction to a fine of \$50,000 or to imprisonment for two years or to both; or
- (b) on conviction on indictment to a fine of \$100,000 or to imprisonment for two years or to both.

I understand that it is a requirement under regulation 9 of the Anti-Money Laundering and Terrorist Financing (Non-Regulated Service Providers) Regulations 2022 that the Financial Intelligence Unit be provided with written notice of any change in the information required to be registered under regulation 3.
